AHN is Officially Accredited in Clinical Integration and Employer Based Population Health!

As you all know, we have been busy for the last several months working to elevate our performance to the next level. In order to receive an objective validation of our excellence in utilization of evidence-based solutions, commitment to continuous quality and process improvement, and last but not the least, provide ourselves with a competitive advantage in the market/state, we ventured into a dual accreditation journey with URAC.

We are excited to announce that we have received formal notices that the URAC Accreditation Committee voted to grant AHN **full accreditation for both Clinical Integration version 1.0** and **Employer Based Population Health version 1.0.** Our accreditation in both programs is effective from March 1, 2023 to March 1, 2026.

AHN is the **first Clinically Integrated Network (CIN) in the industry** to attain *dual accreditation* in Clinical Integration and Employer Based Population Health. This unique accomplishment directly aligns with our mission to build healthy communities in Arkansas.

Our Journey

It's been quite a long journey, starting in July 2021 when we first executed our URAC agreement. After more than a year of developing policies and procedures to align with URAC standards, we submitted our URAC Desktop Review in August 2022. One month later, in October 2022, we received 100% Completion from URAC — a huge reward for our work so far — and moved on to preparing for our URAC Validation on-site review.

URAC surveyors, CHI St. Vincent and CommonSpirit leadership, several physicians from our network and their administrative staff, and our AHN employees, gathered on January 31st for the formal review. In our closing discussion, the URAC surveyors shared how impressed they were by our

organization and that they would be recommending us for full accreditation in both Clinical Integration and Employer Based Population Health. The URAC Accreditation Committee formally voted on our application in late February, and we are now officially dually accredited with URAC.

Although this is a massive achievement, the real work begins now to ensure that we continue to comply with URAC's exacting standards throughout the next 3 years. We are confident our practices and procedures will carry us on into the future.
